## ORDER PROCESS

- Step 1: Contact us with your enquiry either by phone, fax or email using the contact details provided.
- Step 2: We will reply to your request with detailed information on our product ranges.

- Step 3: After making your selection, send us an email with your proposed Order stipulating quantities and preference of either air or sea freight.
- Step 4: We will provide you with a detailed quotation and interim invoice for your approval. All quotations will be in Australian dollars (AUD).
- Step 5: If you agree to the interim invoice, we will create a commercial invoice which will include banking details. Payment can be made either by Letter of Credit or Telegraphic Transfer prior to despatch.
- Step 6: Upon receipt of payment, your order will be picked and packed and all the necessary air/sea freight documentation completed for immediate despatch.
- Step 7: We will deliver your order to the freight forwarder FOB or organize FIS and courier the final paperwork to you to allow customs clearance when your order arrives.

## ORDER QUANTITIES

All prices quoted are FOB Brisbane. Gourmet Ice Cream Products can organize FIS sea or air freight if requested by our export customers.

We would obtain the most competitive price at the time of ordering to freight your order to the port of your choice. Freight charges would be added to your final invoice and therefore payable before the order is despatched.
